

TCWS TERMS AND SERVICE

This document acts as an agreed upon Terms and Service ("Terms", "Terms and Service ") between you ("User" or "you") and TCWS INTERNATIONAL INC ("Tea Coffee Water Snacks" or the "Company" or the "TCWS"). You accept these Terms when you purchase Tokens ("Tokens") or use Tea Coffee Water Snacks services or any other features, technologies or functionalities offered by TCWS INTERNATIONAL INC or heirs, successors, or assigns on the company website at <https://tcws.io> ("Site") or through any other means (collectively, "Services"). The terms "us" or "we", refer to TCWS INTERNATIONAL INC.

Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Service. We will provide notice of any amendment to these Terms by posting any revised terms to the Site and updating the "Last updated" field above accordingly or by any other method we deem appropriate. We are not obligated to provide notice in any other method beyond these. Any change to these Terms will be effective immediately upon such notice and apply to any ongoing or subsequent use of the Site or Services.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you may not access the Service.

1. Eligibility

By registering to use a TCWS account, you represent and warrant that you are at least eighteen (18) years of legal age to form a binding contract under applicable law, and are eligible to use the internet and services like those provided by TCWS (according to the laws of the United Kingdom and any relevant jurisdiction in which you reside), and have not had your right to use our services previously suspended or revoked by us.

2. Illegal and Prohibited Use

You represent and warrant that you will not use the Site or Services for any criminal, illegal, or otherwise prohibited use, including (but not limited to) activities related to money-laundering, drug trafficking, human trafficking, weapon trafficking, terrorism, securities fraud, or tax evasion. You represent and warrant that you will not use our Site or Services to assist any other party in such illegal activity.

You represent and warrant that you will not in any way use the Site or Services to: distribute spam, junk communications or chain letters; reverse engineer or otherwise improperly access any of the Site's or the Platforms underlying code or technical mechanisms; cause damage to the Site or TCWS through any means, including (but not limited to) through the use of hacking, malware, viruses, illegitimate credentials, phishing, brute force attacks, SQL exploits, or any other method of detrimentally intercepting, interrupting, or damaging any information or functionality related to the Site. You also agree not to transfer access to your Account (as defined below) or any other rights granted to you by these Terms.

3. Registration and Account

The use of our Services requires you to create an account with TCWS ("Account"). You warrant and represent that all information provided when creating such an Account is current, complete, and

accurate. You agree to promptly notify TCWS for any changes to any information that would cause the information provided upon your Account's creation to no longer be current, complete or accurate. You also warrant and represent that you understand that no Account will be fully created until you confirm your email address in a manner deemed suitable by us.

TCWS may request you to provide additional information such as proof of your identity, physical address and source of funds at any time to use our Services. If you refuse to provide such information or it will be determined that you may not use our Services for any reason, you will be denied Services. In such case, your purchase of Tokens will be cancelled and you shall not receive any refund, if any.

You agree that you exclusively will access and use your Account, and may not transfer the right of its use or disclose any log-in credentials to a third party then TCWS will not be hold responsible. You agree to take full responsibility for any activity that occurs through the use of your account, and cannot transfer this obligation to any third party. You agree to notify TCWS in the event that you discover or suspect any security breaches or vulnerabilities related to the Site or Services.

4. Damages

Use of the Internet may not be secure. You agree that TCWS is not responsible whatsoever for any damages caused by the interception, loss or alteration to any information sent over the Internet. While TCWS shall take reasonable steps to ensure the security and privacy of any information transmitted during your use of our Services, in no event will any such information be considered "confidential" or its disclosure to a third party, accidental or otherwise, cause liability against TCWS, even if it occurs as a result of negligence.

TCWS takes every reasonable precaution to prevent and mitigate attacks. However, these problems still may occur from time to time for reasons that are out of control. If the Site or any Tokens located on the Site has been compromised or is under attack, TCWS reserves the right to immediately stop all Services provided through the Site. If it is determined that such an attack caused an associated Token to rapidly lose value or otherwise cause or threaten to cause damage to the Site, or other users, TCWS may immediately discontinue all activity regarding to such Token entirely at its discretion. Resolution concerning deposits, withdrawals, Account balances, Services or other disputes related to an attacked Token shall be determined on a case-by-case basis. TCWS makes no representation and does not warrant the safety of the Site and is not liable for any lost value or stolen property, regardless of whether TCWS was negligent in providing appropriate security.

5. Legal, Financial or Other Professional Advice

In no way should our Services be considered legal, financial or any other kind of specialized or expert advice on which the User might detrimentally depend, causing liability against TCWS. 6. Purchase of Tokens

The User can purchase Tokens by transferring acceptable cryptocurrencies to the wallet address provided to your Account or by making USD or Euro payments via bank wire or a third-party payment processor indicated on the Site if any. We may change the methods and forms of payments at any time and at our own discretion.

The transfer of funds for the purpose of purchasing TCWS Tokens shall be treated as a deposit until you complete the purchase to receive any applicable discounts and bonuses. However, if you fail to complete your purchase or request a refund of your deposit then TCWS shall transfer the refund in your account through the same mode which you have used to transfer. 7. License

We grant you a limited, nonexclusive, non-transferable license (“License”) to access and use our Site and Services. Any other use of the Services not expressly permitted by these Terms is prohibited. All other rights are expressly reserved by TCWS and our licensors, including that to any content or functionality as presented on the Site or Services. 8. Termination

We shall terminate or suspend your account without prior notice or liability for any reason whatsoever, including (but not limited to) if you breach any of the Terms. Nothing in these terms or in any other communication or action by TCWS or our employees, agents or representatives should be taken as a waiver of any legal remedies available for any event causing termination. All provisions of the Terms which by their nature should survive termination shall survive termination, including (but not limited to) ownership provisions, disclaimers or limitations of obligations or liability, and indemnity.

9. Copyright

You agree that any materials, information or communications transmitted between the User and TCWS in any form and by any means are confidential and will become the sole, exclusive property of TCWS. TCWS owns all intellectual property rights to such communications or materials, and can use or disseminate them in a completely unrestricted fashion for any legal purpose, commercial or otherwise, without notifying or compensating you. You hereby waive any right to litigation or recovery for perceived damages caused by the use of this information as is permissible by law.

10. Indemnification

You agree to indemnify, exculpate and hold TCWS, its representatives, affiliates, employees and service providers harmless from any claim or demand permissible by law arising out of or related to the use of the Services, including but not limited to any breach by you of these Terms or violation of any law, rule, or rights of a third party. You agree to pay for any legal fees or other costs that incurred by TCWS or any other indemnified parties as a result of your actions.

11. Disclaimer of Warrants and Guarantees

TCWS does not guarantee any level of performance or the continued, uninterrupted availability of our Services. We do not guarantee the accuracy of any information provided on the Site. We hereby disclaim all warrants and guarantees that not expressly made in these Terms.

12. Applicable Law and Venue

The validity, interpretation, construction and performance of these Terms, and all acts and transactions pursuant hereto and the rights and obligations of the parties hereto shall be governed, construed and interpreted in accordance with the laws of United States, without giving effect to principles of conflicts of law.

13. Survival and Severability

Any portion of these Terms that reasonably should survive the termination of your License or any other agreement is hereby agreed to do so. If any provision of these Terms is deemed illegal, invalid or otherwise invalid for any reason, then that provision will be severed and the rest of these Terms will remain intact and enforceable.

14. Integration

Our failure to exercise or enforce any rights or provisions of these Terms does not constitute a waiver of those rights or provisions.
